#### **Purpose:**

Illinois Health Cares advocates for policy reform, public health approaches, prevention efforts and systems change work to promote improved health care prevention and response efforts to violence. The initiative is co-chaired by the Illinois Department of Public Health and the Illinois Violence Prevention Authority and draws on the strengths of many collaborative partners. IVPA funds twelve local communities, one large urban hospital and a statewide collaborative to carry out the Illinois Health Cares mission.

#### **Focus:**

Health care professionals are in an excellent position to offer prevention messages and to intervene early in the cycle of violence. The general population and those who are abused come into contact with health professionals more often than they do law enforcement officers, judges or advocates from local violence prevention agencies. If you are working in a direct practice, clinic or hospital setting it is likely that you are encountering patients on a regular basis who are suffering the effects of abuse and violence. Failing to respond to patients places them at increased risk for future abuse and exacerbated chronic and acute illnesses, mental illnesses and substance abuse; and, remaining silent on prevention issues deprives you and your institution of the opportunity to be a change agent in efforts to lessen violence.

#### **Who Should Attend:**

This training is directed towards physicians, nurses and all other health care providers and administrators as well as social workers, advocates and supporting staff who work with health care professionals. It is the hope of Illinois Health Cares that those who attend this training of trainers will return to their local communities and offer training/technical assistance to their colleagues and peers on the health care response to domestic/intimate partner and sexual violence.

#### Overview

**Instructor: Jacquelyn C. Campbell, PhD, RN, FAAN**

Dr. Campbell's overall research and policy initiatives are in the area of family violence against women, with continuous research funding since 1984 from NIH, NIJ, CDC and DOD, including being Principle Investigator on three NIH, 2 CDC, 1 Department of Defense and 1 National Institute of Justice funded research grants on battering. Specific research areas include risk factors and assessment for intimate partner homicide, abuse during pregnancy, marital rape, physical and mental health effects of intimate partner violence, prevention of dating violence and interventions to prevent and address domestic violence. Her research results are used as the basis of health policy recommendations to state, national and international organizations. Dr. Campbell's awards include Fellowship in the American Academy of Nursing, the Kellogg National Leadership Program, a Robert Wood Johnson Urban Health Fellowship, the Simon Visiting Scholar at the University of Manchester in the UK, and elected membership in the Institute of Medicine. She has authored or co-authored more than 125 articles and chapters, mainly about battered women and family violence and is author, co-author or editor of 5 books. Dr. Campbell has also been working with shelters and advocacy organizations for the last twenty-five years including leading support groups and serving on four shelter boards. Currently, she is on the Boards of Directors of the Family Violence Prevention Fund in San Francisco, the House of Ruth in Baltimore, and has served on the congressionally appointed Department of Defense Task Force on Domestic Violence.

**Illinois Health Cares** is active at national, state, and local levels promoting improved health care prevention and response efforts to domestic/intimate partner, elder and sexual violence. The initiative is co-sponsored by the Illinois Department of Public Health and the Illinois Violence Prevention Authority and draws on the strengths of many collaborative partners.

#### Focus: Self-Neglect Among the Elderly

#### Nationally recognized trainers/experts will include:

**Dr. Carmel Bitondo Dyer, MD**, is associate professor of medicine at Baylor College of Medicine and Director of the Harris Hospital District Geriatrics Program. Dr. Dyer divides her time between clinical practice, departmental administration, research and multidisciplinary leadership. She recently set-up a multi-disciplinary group, the Texas Elder Abuse Mistreatment Team (TEAM) Institute, co-authored research on geriatrics as an interdisciplinary phenomenon, and conducted clinical and didactic research in conjunction with area Adult Protective Services. In 2004 the TEAM Institute received NIH funding and established the Consortium for Research in Elder Self-Neglect.

**Dr. Mark Lachs, MD, MPH**, is Professor of Medicine and Co-Chief of the Division of Geriatrics and Gerontology at Weill Medical College. He is also director of Cornell's Center for Aging Research and Clinical Care and Director of Geriatrics for the New York-Presbyterian Health System. Dr. Lachs' research, teaching, and clinical experience center on elder abuse and improving the quality of life for elder adults. The focus of his research includes the identification of risk factors for reported elder mistreatment and more recently, the survival of older adults who have experienced mistreatment. In addition to an NIA academic leadership award, Dr. Lachs is the Paul Beeson Physician Scholar from the American Federation for Aging Research and the Irene F. and I. Roy Psaty Distinguished Professor of Clinical Medicine.

**Terry Fulmer, PhD, RN**, is currently the Erlene Perkins McGriff Professor and Dean of the New York University School of Nursing. Elder abuse is a focus of Dr. Fulmer's research. In addition to publishing scores of papers, sitting on key panels, and training health care professionals to detect abuse and neglect, Dr. Fulmer also played a key role in the development of the Elder Assessment Instrument, a screening checklist now used nationwide. She worked with Yale faculty on a project aimed at improving hospital care for older adults; through this project the Geriatric Resource Nurse (GRN) model was developed. GRN programs provide registered nurses with on-going intensive hospital-based mentoring and training in the care of older patients so they can serve as go-to experts for other nursing staff.
