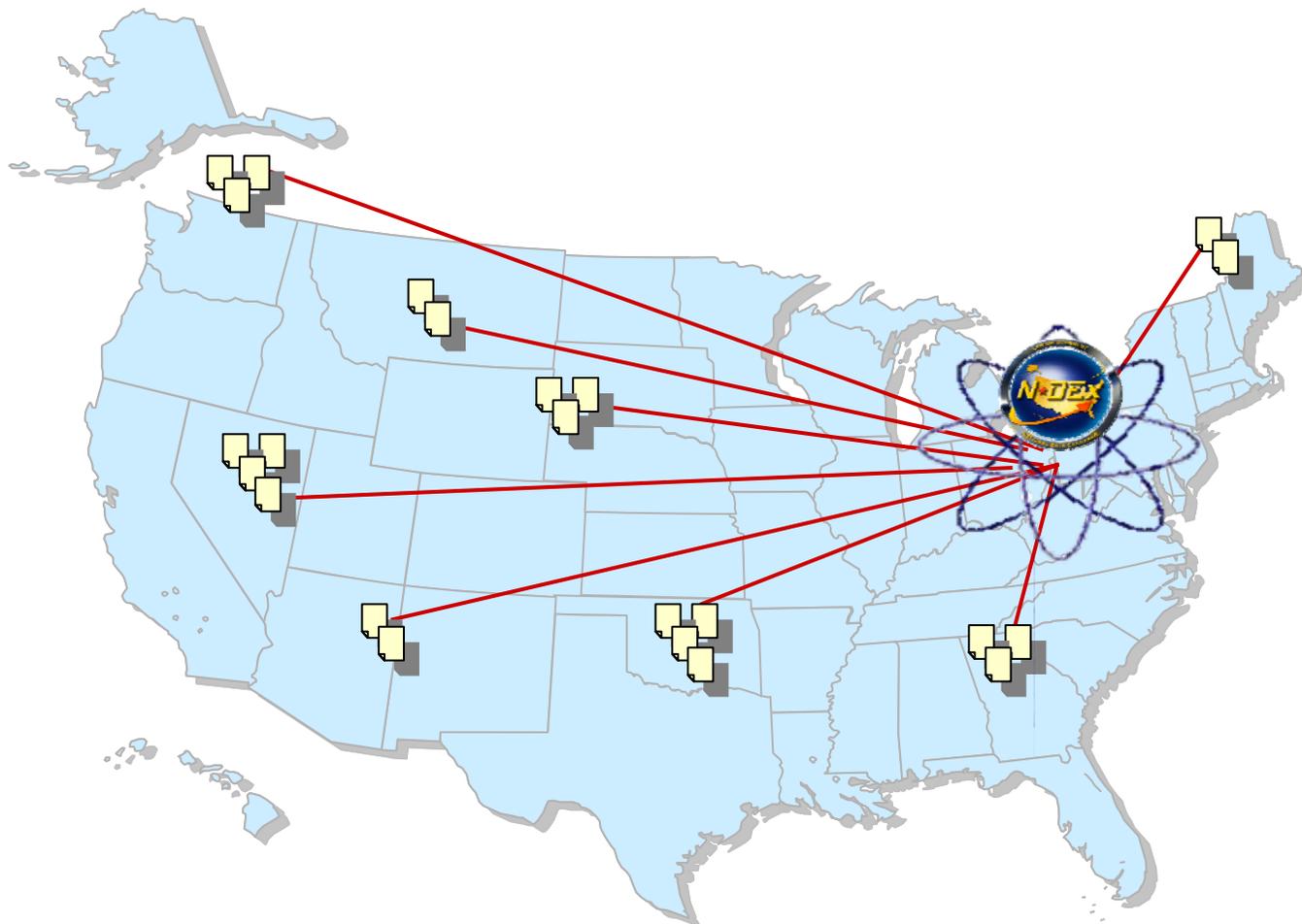
N-DEx Mission

N-DEx will provide law enforcement agencies with a powerful new investigative tool to Search, link, analyze and share criminal justice information such as, incident/case reports, incarceration data, and parole/probation data on a national basis to a degree never before possible.



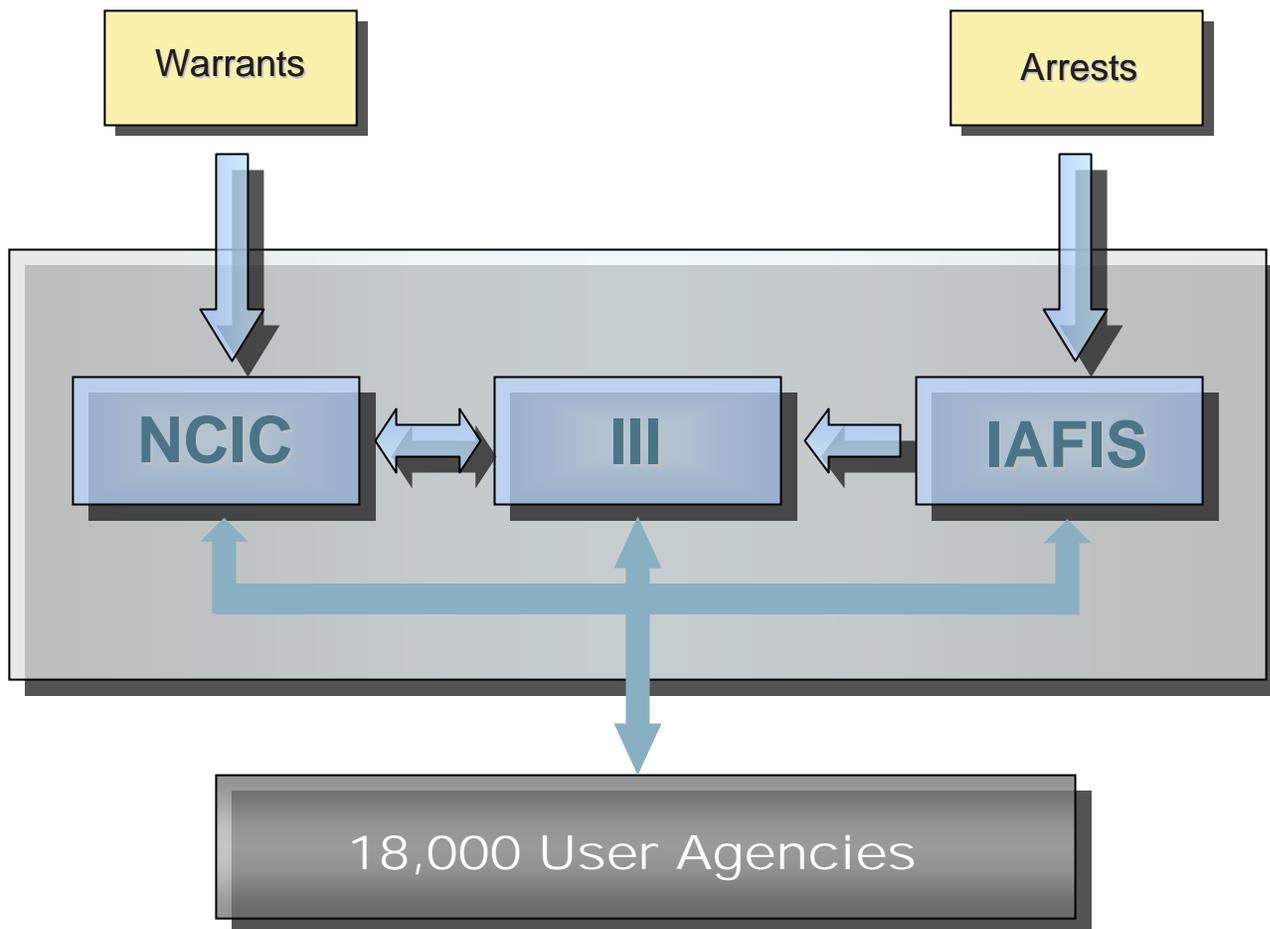
N-DEX Vision

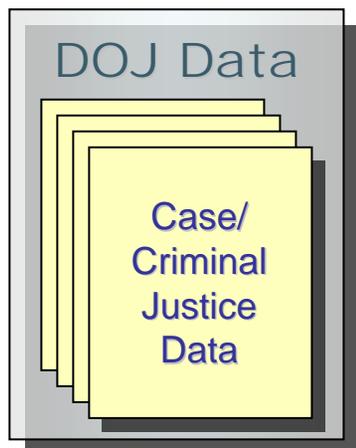
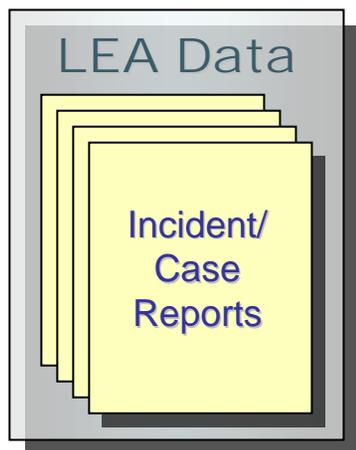


CJIS Current Information Sharing

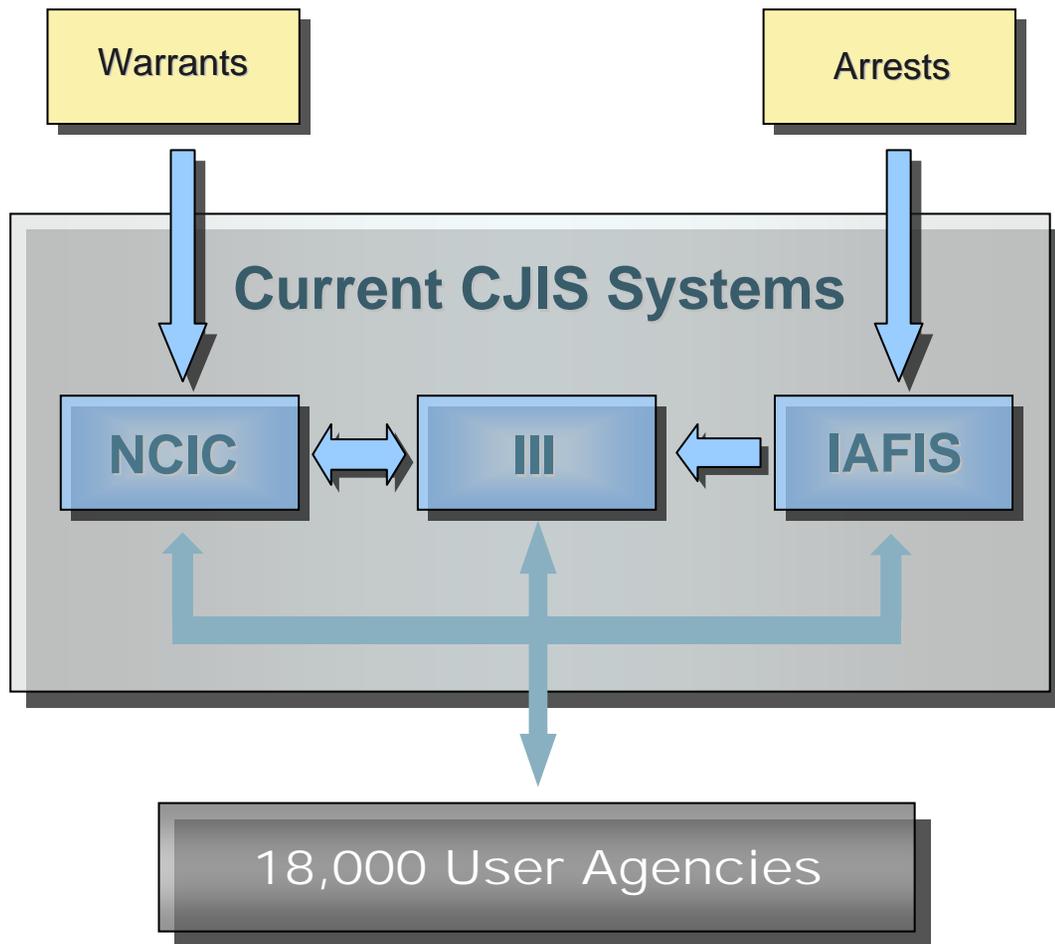




CJIS Information Sharing Gap

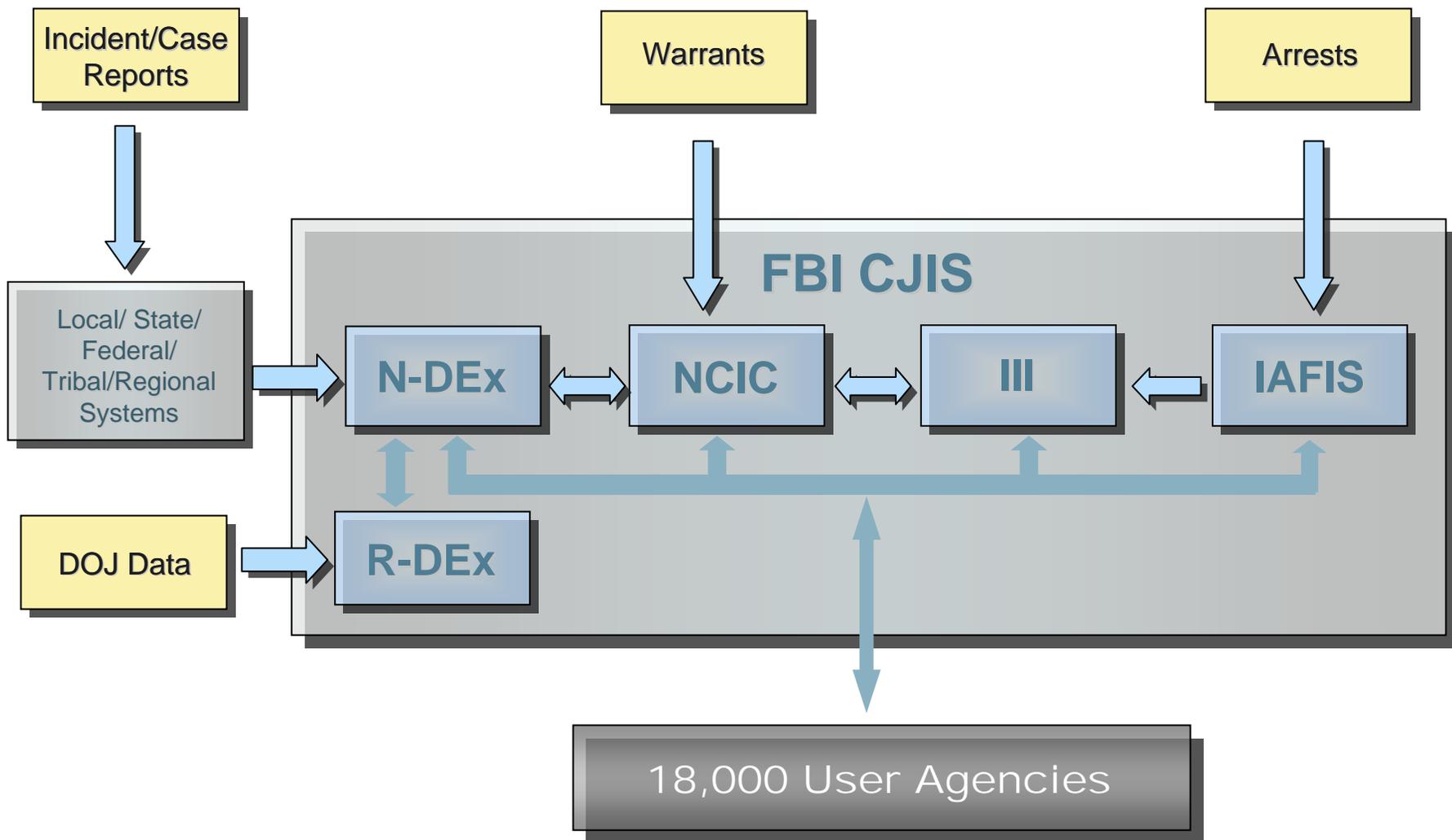

CJIS Information Sharing With N-DEX/R-DEX Integration

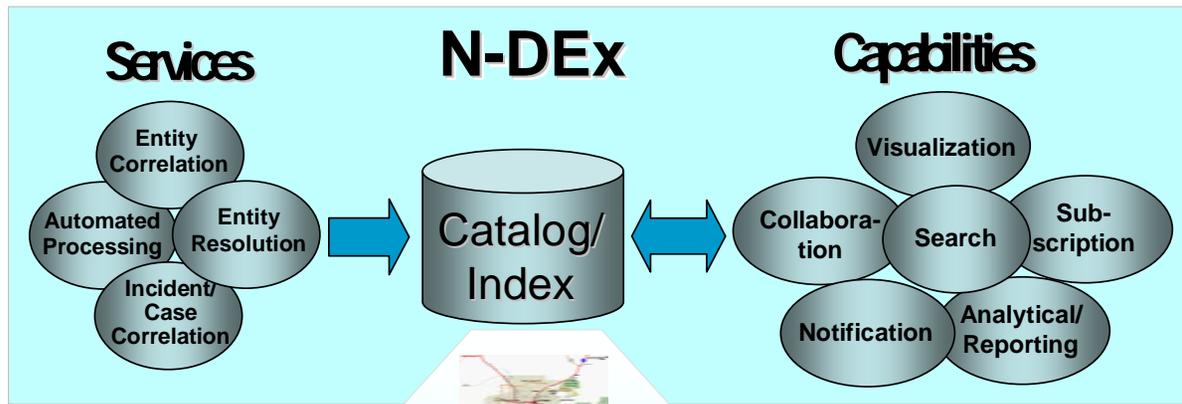
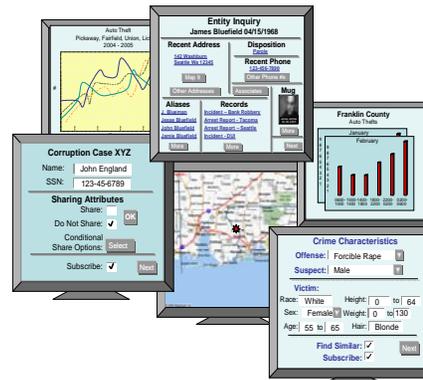
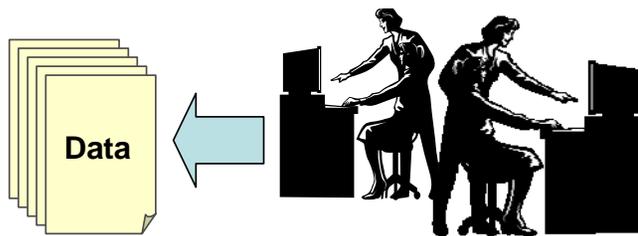

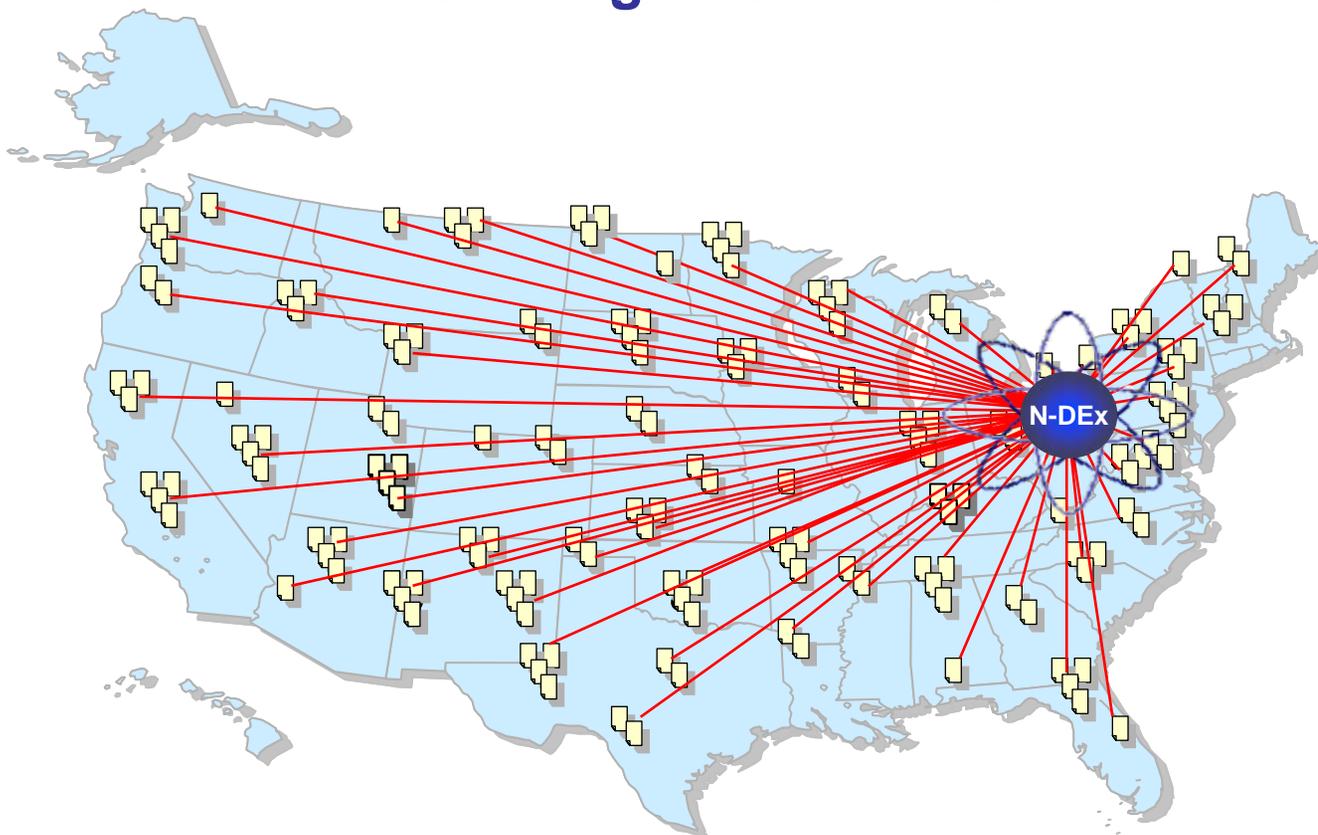

National Sharing of Criminal Justice Data



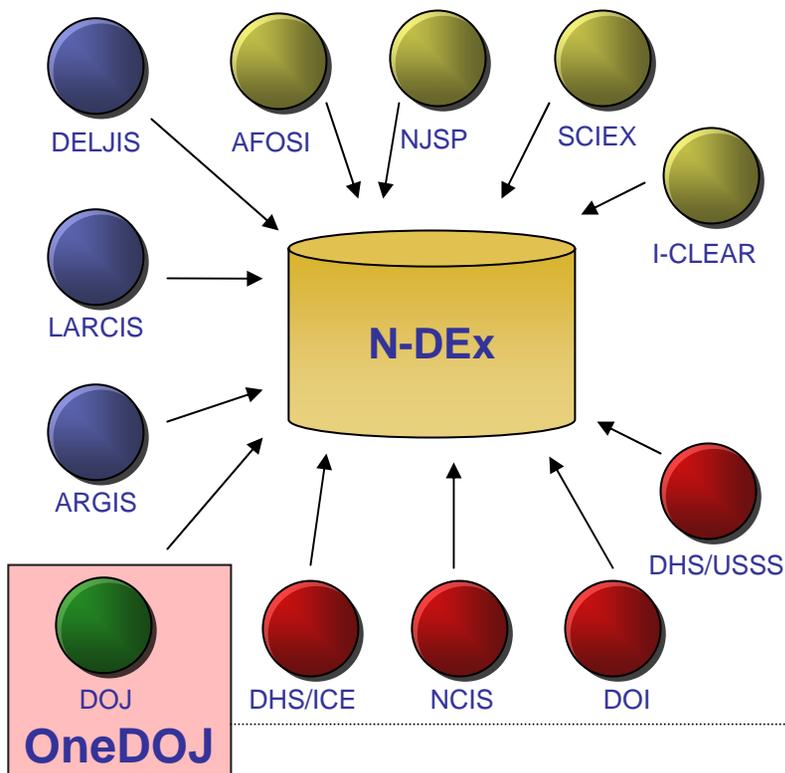

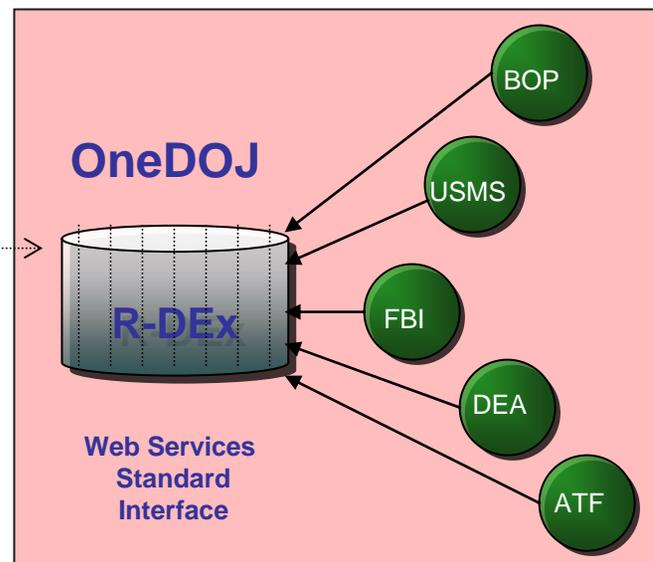
Local, State Federal, Tribal, Regional Law Enforcement Data (N-DEX)



N-DEX / R-DEX Relationship



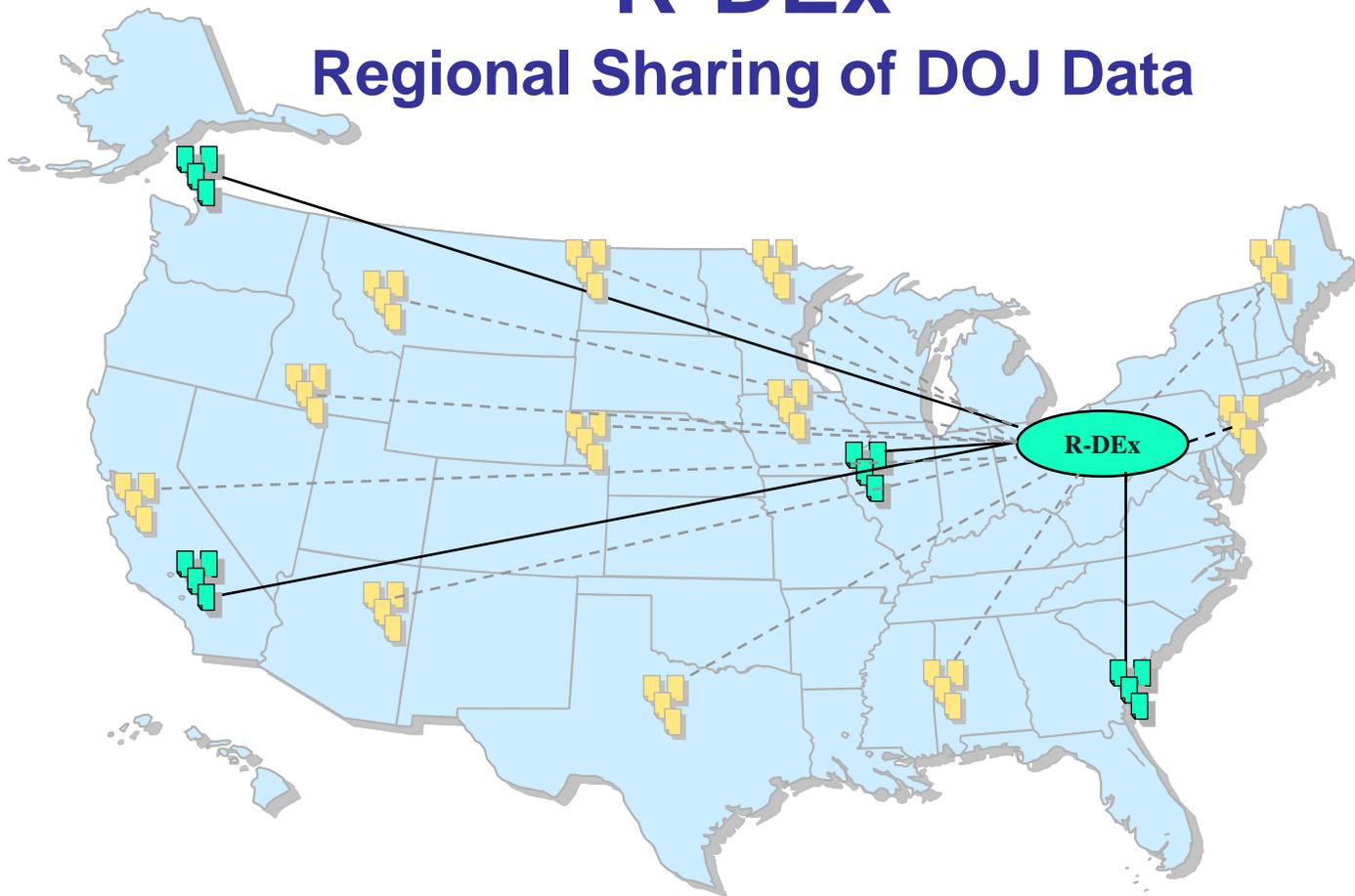

= Current DOJ Data Sharing Participant Locations

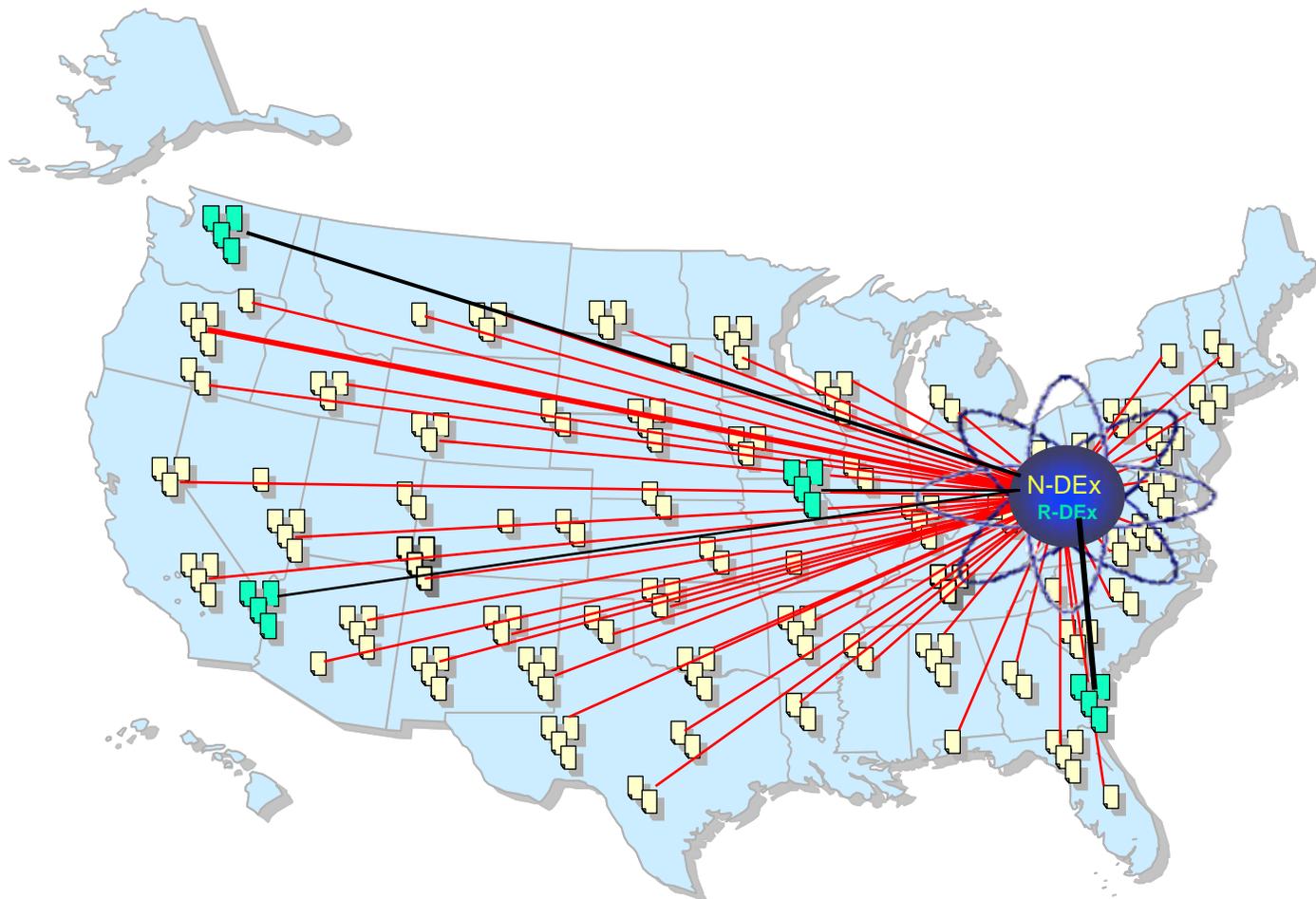


= Potential Future DOJ Data Sharing Participant Locations

N-DEX Functional Integration

■ End-User Browser

- LEA users will be provided the ability to access N-DEX directly through a web browser
 - Web Services for delivery of data scheduled for Increment 1.
 - Web Services for receipt of data scheduled for Increment 3.

■ Web Services

- All N-DEX user level capabilities will be available to external LEA systems through web service interfaces
- Example - RMS or regional system may wish to integrate N-DEX capabilities into the local system's user interface



N-DEX Data Standards

- **Extensible Markup Language (XML) - structured language for describing information being sent electronically to N-DEX.**

- **The National Information Exchange Model (NIEM) is using the GJXDM to build a common XML data exchange standard for information sharing among:**
 - Department of Homeland Security
 - Department of Justice
 - Justice, public safety, homeland security, and intelligence.

Prototype activities will support the following program initiatives

- Support and establish the N-DEx data set and data submission guidelines through GJXDM/NIEM
 - Working with Georgia Tech Research Institute to develop Law Enforcement N-DEx Incident Information Exchange Package Documentation (IEPD) released February 2007
- Support the evolution of N-DEx business and policy rules through the APB
- Provide law enforcement active participation and submission/validation of existing RMS data



N-DEx Prototype

- Los Angeles Regional Crime Information Center (LARCIS)
 - 506,071 Submissions submitted (May 14, 2007)
 - Mapped data to N-DEx Bundle Version 1.0.4
 - Daily submissions via standard web interface over the CJIS Wide Area Network

- Delaware Justice Information System (DELJIS)
 - 22,362 Submissions submitted (May 14, 2007)
 - Mapped data to N-DEx Bundle Version 1.0.4
 - Daily submissions via standard web interface over the CJIS Wide Area Network

- San Diego Automated Regional Justice Information System (ARJIS)
 - 837,284 Submissions submitted (May 14, 2007)
 - Mapped data to SEARCH IEPD
 - Batch submissions through SFTP

- Marietta, Georgia
 - 1000 Submissions submitted (May 14, 2007)
 - Mapped data to N-DEx Bundle Version 1.0.4
 - Daily e-mail submissions

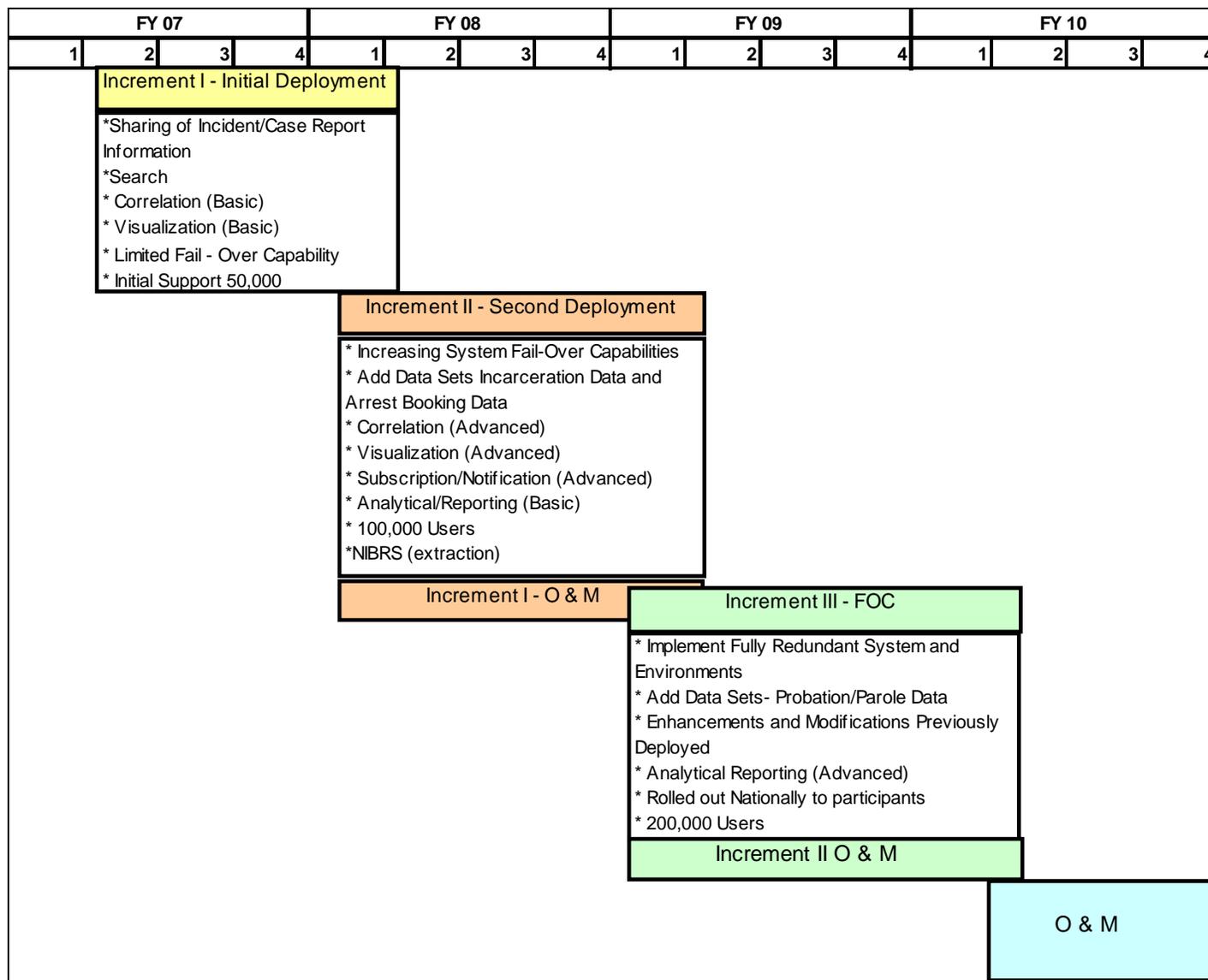

N-DEx / NCIC Integration

- **N-DEx will be required to query NCIC via NCIC transactions such as the QW, QG, QA, and QV transaction.**

- **N-DEx will search 16 of the 21 NCIC files, to include Interstate Identification Index (III) search.**
 - Originating Agency Identifier
 - Wanted Person
 - Missing Person
 - Foreign Fugitive
 - U.S. Secret Service Protective
 - Vehicle
 - License Plate
 - Boat
 - Vehicle/Boat Part
 - Article
 - Gun
 - Violent Gang and Terrorist Organization
 - Convicted Person on Supervised Release
 - Convicted Sexual Offender Registry
 - Identity Theft
 - Immigration Violators



N-DEX Commitment

- **State Agencies**
 - Alabama – Upgrading state system that will be N-DEX compatible; MOU
 - Colorado – Conducting development efforts to build state system to be N-DEX compatible; MOU
 - Connecticut – Five agency accident form project as proof of concept, mapped to SEARCH IEPD for transition to incident data
 - Delaware – Actively submitting N-DEX compliant incident data; MOU
 - Florida – Building state system that will be N-DEX compatible
 - Illinois – New state system that will be N-DEX compatible; MOU
 - Kansas – Upgrading state system that will be N-DEX compatible; MOU
 - Michigan – Mapping to N-DEX IEPD; MOU
 - Missouri – Expanded state system; MOU
 - Nebraska – Test data submitted to prototype and validated; MOU
 - New Jersey – Expanding system to be N-DEX compatible
 - Nevada – Obtaining funds to upgrade state system that will be N-DEX compatible; MOU
 - Ohio – Mapping to N-DEX IEPD, test data projected by May 2007; MOU
 - Oklahoma – State system that is N-DEX compatible; MOU in process
 - Oregon – Mapping to N-DEX IEPD; test data projected by Aug 2007, MOU
 - Pennsylvania – Conducting development efforts for connectivity to N-DEX, MOU in process
 - South Carolina – State system is N-DEX compatible; MOU
 - Tennessee – State system that is N-DEX compatible; Mapping to N-DEX IEPD; MOU
 - Texas – Mapping data to N-DEX IEPD, MOU, test data July
 - Virginia – Building state system that will be N-DEX compatible; MOU, partial participation through Regional System, LInX
 - West Virginia – Exploring available resources to strategize plan for N-DEX participation; MOU
- **Local/Regional Agencies**
 - LARCIS, LA County, CA – Actively submitting N-DEX compliant incident data; MOU
 - ARJIS, San Diego, CA – Date mapped to SEARCH IEPD, test data submitted and validated, four years of data received; MOU
 - ARIES, Northern CA – mapping to N-DEX IEPD, test data projected by May 2007, MOU
 - Marietta, GA – N-DEX compatible mapping complete; MOU
 - LInX Hampton Roads – MOU
- **Federal Agencies**
 - AFOSI – Upgrading records management system that will be N-DEX compatible; mapping to N-DEX IEPD



N-DEX Data Sensitivity Levels

The entering agency categorizes data submitted to the System into levels of sensitivity upon which the dissemination of the information/data is controlled.

APB Approved Sensitivity Levels:

LEVEL 1 - SHARED

N-DEX shall provide the capability for data contributors to allow sharing data it submits to N-DEX

LEVEL 2 – CONDITIONALLY SHARED

N-DEX shall provide the capability for data contributors to specify “pointer based” sharing of data. (i.e. provide POC information only)

LEVEL 3 – NOT SHARED

N-DEX shall provide the capability for data contributors to restrict data its submits to N-DEX. This level is reserved for the most restricted investigations and investigative information.

- This capability will allow agencies to submit information for sharing but control the dissemination of sensitive information to protect investigative equities.
- Sensitivity applied to specific data elements if needed



Privacy Impact Assessment

- N-DEX Privacy Impact Assessment (PIA) for N-DEX was approved by the Office of General Counsel (OGC) on 05/02/2006
- Subsequent changes to the prototype Memorandum of Understanding (MOU) will be added via an addendum to cover the FOIA issues.
- The PIA was signed and approved by DOJ Privacy Officer on 04/06/2007.
- A Privacy Act System of Records Notice and Exemption Notice is prepared and ready for publication pending CJIS Management Approval.
- An Operational MOU is being drafted and will replace the current Prototype MOU.



Privacy Advocacy Group

- First Privacy SME meeting held at CJIS on 06/13/2006 . Privacy Project representation included the following:

 - Texas Innocence Project
 - American Indian Development Associates
- FACA sanctioned through APB
- No previously unaddressed privacy issues were identified by the group
- Meeting held on 01/12/2007 with ACLU Director Technology and Liberty Project discussing N-DEEx R-DEEx relationship
