IIJIS Implementation Board

- Created by Governor Rod R. Blagojevich in 2003 by Executive Order No. 16
- An intergovernmental effort dedicated to improving the administration of justice in Illinois.
- A collaborative effort charged with enhancing public safety.
- Promotes the integration of justice information systems and coordinates the development of systems that enhance integration.



IIJIS Implementation Board

- Board is comprised of 26 members of the justice community who serve without compensation.
- The work of the Implementation Board has been divided among four committees: (1) Planning and Policy Committee; (2) Technical Committee; (3) Outreach Committee; (4) Funding Committee.
- An Executive Steering Committee helps to coordinate the IIJIS Effort.

IIJIS Technical Committee Objectives

- Establish standards/regulations for data sharing and infrastructure development
- Secure, reliable, effective, and efficient information technology (IT) infrastructure that facilitates justice information sharing.



IIJIS Technical Committee

Key Accomplishments

- Adoption of the Global Justice XML Data Model (GJXDM) as a multi-use standard as a “best practice” for inter-agency data exchanges.
- Adopted Electronic Fingerprint Submission Specifications (EFSS) as the mandatory compliance standard for submission of fingerprints to Illinois State Police/Bureau of Identification.
- Participate with Planning & Policy subcommittees due to interrelated nature of the work.



IIJIS Technical Committee

Future Initiatives

- Develop XML reference documents for commonly exchanged criminal justice documents, where existing ones have not been generated.
- Publish “best practice” and reporting specification standards on IIJIS Website.
- Create architecture and infrastructure baseline.
