WHAT IS INTEGRATION?

Integration is the ability to share critical information electronically at key decision points throughout the justice system.

WHY IS INTEGRATION IMPORTANT?

Justice cannot be properly administered without complete and accurate information. Many inadequacies exist today in the collection, storage, and dissemination of information needed to effectively administer criminal justice and protect Illinois citizens. While much information is stored electronically in Illinois, very little of it is available quickly across agency boundaries. Information that has been integrated from all Illinois justice agencies will be more complete, timely, and accurate, and creates more efficiency and effectiveness in the administration of justice.

VISION

Illinois can become a nationally recognized leader with the creation of statewide justice information sharing capabilities that provide secure and timely access to accurate and complete information throughout the justice system. Through integrated justice information sharing we will enhance the safety, security, and quality of life in Illinois, and improve the quality of justice and the efficiency of operations, and ensure informed decision-making, while protecting privacy and confidentiality of information.

MISSION

IIJIS strives to:

- Bring stakeholder organizations together to comprehensively and effectively plan justice information systems.
- Provide leadership in the planning and facilitation of electronic information sharing.
- Build and expand the range of effectiveness of information systems and sharing capabilities.
- Improve the effectiveness, efficiency, timeliness, accuracy, and completeness of information.
