1. Public hearings in Springfield and Chicago.

Mr. Sullivan mailed to all Committee members a typewritten transcript of the audio recording of the Committee's public hearing held in Springfield, Illinois on November 13, 2006, and Mr. Baroni mailed to all members a copy of the audio recording of that hearing. The Committee unanimously approved the typewritten transcription, which Mr. Baroni will have posted on the CJIA website.

The Committee discussed the February 26, 2007 public hearing. Mr. Baroni emailed all Committee members a copy of the court reporter's transcript of that hearing. In light of the size of the transcript (over 200 pages), Mr. Baroni will mail a hard copy to all Committee members. The Committee agreed on the utility of public hearings and will conduct more in the future.

2. Governor's appointment to the committee.

The Committee discussed the status of the Governor's vacant appointment to the Committee. Mr. Baroni said no change in status to date. Mr. Nora suggested the Governor may wish to appoint a law enforcement representative. Mr. Sullivan and several other members of the Committee agreed that the Committee would be well served by a law enforcement member, and a number of potential candidates were suggested by members. Mr. Sullivan agreed to talk to the legislative members of the Committee to determine the best way to persuade the Governor to appoint a member quickly.

The new head of the Illinois State Police Forensic Services is Colonel Jack Garcia. The Committee agreed that the issue of DNA compilation and testing relates to the work of several subcommittees, and therefore we should invite Mr. Garcia to speak to the full Committee. Mr. Sullivan agreed to contact Mr. Garcia.

(3) Report of Subcommittee 3 – Trial court proceedings.

Mr. Howard said the subcommittee had not met since the last full Committee hearing. The subcommittee is scheduled to meet Mt. Vernon, Illinois to speak to Judge Terry H. Gamber, 2nd Judicial Circuit. Judge Gamber presided over the *People v. Sutherland* capital case.
