# **Research Update**

This update covers the work and accomplishments of R&A since mid-September 2020.

### **Grant Awards**

R&A was awarded the following new research grants:

- A \$30,000 federal award through Cook County Health for a study of recovery housing for Cook County probationers.
- A \$29,000 award through University of Illinois' Center for Prevention Research and Development for the analysis of juvenile justice data for federally mandated reporting. This analysis will include data on racial and ethnic disparity.

- The Virtual Criminology Consortium (CrimCon) virtual criminology research conference, with presentations on An Exploratory Study on the Experiences of Female Police Leaders and *A Study of Drug Testing Practices in Probation*.

### **ICJIA-led Task Force**

The Traffic and Pedestrian Stop Data Use and Collection Task Force convened twice during the fall to discuss Illinois traffic and pedestrian stop data collection, including methods used to collect and analyze the data. The Task Force will meet quarterly through 2021 to determine how to best detect and measure potential racial bias in traffic and pedestrian stops. A final report will be completed in Spring 2022.
