## Attorney Victims of Crime Act

The Illinois Criminal Justice Information Authority ("the Authority"), based in downtown Chicago, is seeking qualified candidates for the position of Attorney for the Victim of Crime Act (VOCA) grant. Under the direct supervision of the General Counsel/Chief of Staff, the attorney for the Victim of Crime Act (VOCA) grant acts as the liaison for the Office of the General Counsel (OGC) to the Federal and State Grants Unit for VOCA related matters to ensure compliance.

The VOCA attorney formulates and implements policies and procedures for the administration of VOCA funds in Illinois; reviews and analyzes Requests for Proposals and contracts related to VOCA grants made by the agency to ensure compliance with state and federal laws as well as agency rules and policies; consults with and advises other agency staff and community stakeholders regarding the application of laws and regulations. The VOCA attorney collaborates with the Research and Analysis unit to develop priorities and policies related to VOCA funds; provides policy-based and research-driven advice to agencies, community stakeholders, and grantees regarding the use of VOCA funds; drafts proposed legislative bills, amendments, resolutions, rules and regulations related to VOCA priorities and goals; travels as necessary to advocate for legislation and policies that align with the agency's VOCA-related priorities and goals. The VOCA attorney also conducts complex legal research and writing related to any legal issues pertaining to VOCA and/or the agency's administration of VOCA funds; conducts negotiations with government officials, grantees, or vendors regarding interagency agreements, VOCA grant agreements, or service contracts related to VOCA grants.
