For Chicago cases: obtain your rap sheet from Chicago Police Headquarters, 3510 S. Michigan, Chicago, IL, no later than 2 weeks prior to the summit.





From NORTHSIDE:

- Take **Red Line** South to 95th St. /Dan Ryan CTA Station
- Walk to 95th CTA (Red) Bus Terminal
- Take **CTA Bus #112** (111th/Pulaski)
- Get off at 111th St. & Western
- Take **Pace Bus #349**
- Arrive at Western & 127th St./Burr Oak Ave.
- **Catch Shuttle Bus* to Eisenhower High School**

- Take **Metra train - RI (Rock Island)**; Direction: Joliet
- Get off at Prairie St. Metra Station
- **Catch Shuttle Bus* to Eisenhower High School**

From SOUTHSIDE:

- At Beverly Hills - 95th St. Metra Station
- Take **Metra train - RI (Rock Island)** Direction: Joliet
- Get off at Prairie St. Metra Station
- **Catch Shuttle Bus* to Eisenhower High School**

From WESTSIDE:

- Take **CTA Blue Line** to Chicago LaSalle St. Station
- Take **Metra train - RI (Rock Island)**; Direction: Joliet
- Get off at Prairie St. Metra Station
- **Catch Shuttle Bus* to Eisenhower High School**
- OR-
- Take **CTA Green Line** to Clark/Lake
- Take **CTA Blue Line** to Chicago LaSalle St. Station

By BUS

At 95th St./Dan Ryan CTA (Red) Bus Station

- Take **CTA Bus #112** (111th/Pulaski)
- Get off at 111th St. & Western
- Take **Pace Bus #349**
- Arrive at Western & 127th St./Burr Oak Ave.
- **Catch Shuttle Bus* to Eisenhower High School**

BY CAR

From SOUTH-EASTSIDE:

1. Take I-94 E.
2. Slight **RIGHT** at I-57 S.
3. Take exit 353 toward 127th St./Burr Oak Ave.
4. Merge onto S. Paulina St.
5. Turn **RIGHT** at W. 127th St./Burr Oak Ave.
6. Turn **LEFT** at Sacramento Ave.
7. **12700 Sacramento Ave., is on the RIGHT.**

From SOUTH-WESTSIDE:

1. Take Hwy. I-80 East
2. Take **EXIT 151B** on the **LEFT** to merge onto I-57 N.
3. Take **EXIT 353 TOWARD** 127th St./Burr Oak Ave.
4. Merge onto S. Marshfield Ave.
5. Turn **LEFT** at W. 127th St. Continue onto Burr Oak Ave.
6. Turn **LEFT** at Sacramento Ave.
7. **12700 Sacramento Ave., is on the RIGHT.**

From NORTHSIDE:

1. Take Hwy. I-94 E.
2. Merge onto I-57 S. via Exit 63 toward MEMPHIS.
3. Take **EXIT 353** toward 127th St./Burr Oak Ave.
4. Stay **STRAIGHT** to go onto S. PAULINA St.
5. Turn **RIGHT** at W. 127th St. / Burr Oak Ave.
6. Turn **LEFT** onto SACRAMENTO AVE.
7. **12700 Sacramento Ave., is on the RIGHT.**

From WESTSIDE:

1. Take Hwy. I-290 W.
2. Keep **LEFT** to take I-88 W. via **EXIT 15A**
3. Merge onto I-294 S. toward INDIANA
4. Take the 127th St. / IL-83 / IL 50 **EXIT** toward CICERO AVE.
5. Turn **LEFT** onto W. 127th St. / IL-83.
6. Turn **RIGHT** onto SACRAMENTO AVE.
7. **12700 Sacramento Ave., is on the RIGHT.**

*Shuttle Bus Service Available

There will be a shuttle bus picking up and dropping off Expungement Summit attendees at 127th St. & Western and the Prairie Metra Station. Pickup at 127th & Western will be every hour beginning at 7 a.m.; at the Prairie Metra Station every two hours beginning at 9:15 a.m. The return shuttle service will be available until the end of the Summit.
