## **Introduction**

With the apparent spread of gangs and criminal activity by young people throughout the state, the Illinois Association of Chiefs of Police sought the Authority's assistance in identifying promising approaches to gangs and youth crime. To that end the Authority surveyed all chiefs, sheriffs and city managers in the state, inviting them to describe programs in their communities they believed were reducing or preventing gang or youth crime. Responses were received from 78 chiefs, sheriffs and city managers identifying 90 programs. These were then organized by type and included in the listing that follows. Those interested in learning more about a particular program should contact the individuals listed for that program directly.

Description: The goal of the program is to reduce gang violence in the South Lawndale Community. This program targets the South Lawndale community in the West Side's 10th Police District, which research shows has a gang homicide rate nearly twice the Citywide rate. Under the program, a team of civilian gang outreach workers maintain regular contact with up to 200 known gang members, providing them with crisis counseling, job and school referrals, and other alternatives. The team also works with police to defuse conflicts among street gangs before they turn lethal. Additional probation officers provide close supervision to known gang members, and a Community Advisory Group consults with project staff. In the first year, gang homicide declined (from eight to four) and the rate of increase in aggravated assaults has slowed. In addition, 15 hard-core gang members have been diverted to educational programs and jobs.

During the 1992-93 school year, the School Patrol Unit made more that 9,700 arrests including 59 for aggravated battery, 128 for robbery, 14 for aggravated sexual assault, and 14 for murder. More than 1,500 school related arrests have already been made for this school year.

Its composition includes school patrol officers, youth officers, and district tactical officers who are knowledgeable of the community and sensitive to the problems of school crime, Deployment of the team is based on crime reports, information from school principals and the community, and input from local police personnel. In just its first two weeks the School Zone Mission Team recovered five guns and five vehicles, and made nearly 100 arrests.
