#### Introduction

Welcome to the second Year 2000 Status Report prepared under the administration of Governor George H. Ryan. In the first weeks of his administration, Governor Ryan created the Illinois Technology Office and unveiled an action plan designed to strengthen his office's oversight of State government's preparations to deal with Year 2000 problems. The plan is designed to speed up the State's preparedness efforts to meet the Year 2000 challenge.

Governor Ryan has instructed each member of his cabinet to make Y2K preparedness a top priority within each of their agencies. He wants them to make every reasonable effort to correct any system deficiencies.

The Illinois Technology Office (ITO) has taken a leadership role in developing assessment and reporting methods for all agencies under the Governor. Among other things, the ITO has directed each agency to describe its business functions; determine the relative importance of each function in day-to-day operations; identify the type and extent of technology used for each function; and assess the overall Y2K-readiness of the technology and components that support the function. While the true focus of this exercise is Y2K preparedness, it also provides a basis for complete understanding of the interaction of each business process with technological processes.

The State's Y2K project was initiated in 1996 with the creation of the State Year 2000 Project Office within the Department of Central Management Services (CMS). The State Year 2000 Project Office, now a part of the CMS State Technology Office, has promoted agency Y2K awareness through seminars, technical programs, Y2K user groups, and various presentations before technical and management groups. It also has provided guides to the agencies for their use, such as the Year 2000 Planning Guide and the Year 2000 Embedded Systems Guide. The State Year 2000 Project Office also continues to collect and process all agency Y2K reports to maintain a Statewide focus on Y2K.

At this time, each agency is working to meet its Y2K challenge. Agencies have designated staff members to be specifically responsible for internal Y2K and embedded systems efforts. Some agencies have taken steps to examine the Y2K-readiness of entities regulated by the State to the extent such readiness could impact the public interest. For example, the Illinois Commerce Commission has carried forth efforts to gather information regarding the status of remediation efforts by investor-owned utilities, and the Office of Banks and Real Estate is examining the Y2K-readiness of State-chartered banks.

Agencies also have been involved in various forms of outreach activities to increase general Y2K awareness. The Illinois Department of Commerce and Community Affairs Manufacturing Extension Program received \$1 million in federal funds to provide help to small manufacturers, farmers, and other Illinois businesses using self-help tools and workshops. This grant will also fund on-site assistance to identify the business' specific Y2K problems and develop plans to deal with them. Other agencies have made similar efforts to guide their constituencies.

The Year 2000 Technology Task Force was created through legislation and established on July 1, 1998. Last fall the Task Force performed a review of the Y2K- readiness of local governments and state universities. After completing this review the Task Force delivered a preliminary report, including suggestions for improved readiness actions, on November 30, 1998. This Task Force continues to meet to monitor the State's overall progress toward preparedness and promote awareness to the various constituencies that its members represent.

One recommendation made by the Task Force was the creation of a Year 2000 Preparedness Council. Governor Ryan created the Illinois Year 2000 Preparedness Council made up of Y2K experts and representatives from local governments and businesses. The Council provides valuable advice to help Y2K preparations within state government and elsewhere throughout the State of Illinois. The Council reports to the Chief Technology Officer and the Governor on the readiness of a wide range of entities to move past December 31, 1999, and into the new millennium.

Governor Ryan also has instructed the Illinois Emergency Management Agency (IEMA) to develop a consequence management plan for the State of Illinois. This amounts to a fine-tuning of the existing state disaster plan in the Y2K context. IEMA's plan focuses on potential needs of the general population and will continuously be broadened to incorporate new information as the year develops.

#### Agency Status Reporting

#### Illinois Year 2000 Project

This report is the second Y2K status report of 1999. It reflects the Y2K status of agencies as of May 31, 1999, with an expanded format.

All status reporting is reviewed and approved by the directors of the agencies. The information is coordinated into an overall State report. The most significant changes to the reporting format established by Governor Ryan's new requirements are listed below:

• The Y2K status reporting schedule requires more frequent reporting, moving from quarterly to monthly reports.

- Individual agency Y2K activities, expressed in terms of project cost and staff-years of effort, are reported.
- Status reporting is expected to be more meaningful because the Y2K-readiness of all business functions, not just computer systems, is being reported.
- The listing of agencies which had supplied a letter to the previous administration indicating they were in full compliance with Year 2000 requirements has been removed from the new report because all agencies, boards, and commissions under the Governor have been, or will soon be, asked to report their Y2K-readiness based upon the new, more complete criteria established under Governor Ryan.
- Prior reports which did not address embedded systems as part of the completion percentages, must now include these systems.

In the past, the status of the State's Year 2000 readiness has been measured by the percentage of computer systems that had been repaired. This is the commonly accepted method used by many organizations, public and private, to measure their Y2K progress.

The State's new reporting methodology attempts to focus on the degree of Y2K readiness of all aspects of a business function rather than merely on the Y2K-readiness of the technology that supports it. The progress of the State's Y2K-readiness efforts will now measure all components, including embedded chips; vendor and business partner assurances of Y2K-readiness; and electronic interfaces with other computer systems, as well as multiple tiers of computer hardware, software applications, and networking components.

To support this reporting methodology, agencies have been asked to describe:

- The agency mission
- The programs, functions, and services of the agency which support the mission
- The technology and infrastructure (computer systems, electronic data interfaces, embedded systems, and vendors and suppliers) that support each of the functions
- The Y2K-readiness of the technology and infrastructure
- Contingency plans for functions in the case of a technology or infrastructure failure.

Additionally, agencies have been asked to assign a tier rating to each program, function, or service. Functions seriously affecting the health, welfare, and safety of Illinois citizens are to be given top priority. Agencies have been asked to classify each of their functions into one of three tiers indicating the immediate criticality of the function.

The following descriptions of the charts and data provide details that, viewed together, create an overall status report of Y2K readiness. Multiple measures such as project cost, staff effort, percentage complete estimates, and functional reporting must be analyzed as an overall picture. No single table paints a complete picture.

Chart 1: Agency progress measured in terms of project cost, staff effort, overall percentage complete, and overall target date complete

As of May 31, 1999, the 60 agency reports reflect that they had completed 83 percent of their overall Y2K effort. This includes computer systems, embedded systems, electronic data interfaces, vendor and supplier relationships, and miscellaneous other Y2K-related projects and activities.

Certain agencies may be involved in activities and have costs related to reviews of the Y2K-readiness of institutions regulated by the State. While a regulatory agency may be vigilant in terms of its internal compliance, the activities and costs of its regulatory responsibilities may extend up to the Year 2000 date change. For instance, the Illinois Office of Banks and Real Estate (OBRE) has performed at least one Y2K examination of every state-chartered bank and trust company since 1997. In addition to monitoring these institutions in accordance with very specific guidelines, OBRE examiners are also performing reviews of bank contingency plans and will be checking on the liquidity levels at these institutions at various points in time between now and the end of the year. These regulatory activities should continue through the Year 2000 date change to reasonably ensure a safe and sound Y2K banking system in the State of Illinois. Therefore, OBRE's Y2K Project, and those of other regulatory agencies, may not be complete until December 31, 1999.

The reporting state offices plan to spend a total of \$144.8 million to become Y2K-ready. Of this amount, \$61.5 million remains to be spent. It is not expected that this amount will be spent by the end of the calendar year. Y2K-expenditures will continue into the first months of the Year 2000. The likelihood that some Y2K expenditures will continue after January 1, 2000 should not be misinterpreted as a lack of preparedness for Y2K on the State's part. In many instances, funds have been obligated and contracts are in place for Y2K-related goods and services. However, actual dollar expenditures are recorded after delivery of goods and services rather than before. Until those goods or services are actually delivered and working for the State, contractors are not paid and the funds are not reported as spent.

Another measure of agency progress can be found by looking at the estimated total staff years of effort and balance of staff years of effort remaining in agency Y2K updates. Agencies are reporting that Y2K projects will take 1,107 staff years to complete. With 247 staff years of effort remaining, 78 percent of the total staff effort to become Y2K-ready has been expended. As described above with project costs, some of the staff effort may not be recorded until after consultants have actually completed their work.

Fifty-five of the 60 reporting agencies estimate an overall target completion date for their Y2K projects prior to January 1, 2000. Five agencies reports dates after December 31, 1999. Y2K projects can be enormously complex, and some agency functions may not be performed until the next calendar year (e.g., certain federal reporting requirements). However, while most experts agree that there will be some Y2K-related problems, it is possible for a problem to occur without impact to any program or service. Because of this, the State has emphasized the prioritization of Y2K projects.

#### Chart 2: Agency functions and functions completed by tier

The 60 reporting agencies have identified 715 business functions. Of these, 105 (15%) are classified as Tier 1 functions, 110 (15%) as Tier 2 functions, and the remaining 500 (70%) as Tier 3 functions. A function assigned to Tier Level 1 indicates that, in the agency's view, this program, function, or service could not be interrupted for more than one day without endangering the public health, welfare or safety of the citizens of the State of Illinois or seriously impacting the State's revenue streams. Tier 2 functions are those that could not be interrupted for more than one week, and Tier 3 functions are all others.

There is no magic formula or absolute guideline for defining functions due to the differing scope, size, and impact of agency programs. Because of this, the initial agency responses are varied. The number of functions reported by agencies ranged from a high of 76 (Human Services) to 12 agencies that reported just a single function. Some of these differences can be explained by the variance in size and scope of agency missions. Agencies also may have differing interpretations of how to define a function for their agency.

In addition to listing the number of agency functions by tier, Chart 2 also lists the number of agency functions reported as Y2K-ready, by tier. Agencies were provided with the following definitions of Y2K-ready:

- Y2K-ready as applied to computer hardware, software, and applications means all technology forming part of, utilized in, or associated with the computer hardware, software, or application (including, but not limited to, information technology, embedded systems, or any other electro-mechanical or processor-based system) will accurately receive, retrieve, process, provide, and output date/time data from, in, and between the twentieth and twenty-first centuries, and from, in, and between the years 1999 and 2000.
- Y2K-ready as applied to electronic data interchanges means that one of the two following requirements is satisfied:
  - (1) the third party that owns, controls, or operates the technology with which the agency's technology interchanges has provided written notice to the agency
    - (A) that such third party's technology is capable of accurately receiving, retrieving, processing, providing, and outputting date/time data from, in, and between the twentieth and twenty-first centuries and from, in, and between the years 1999 and 2000, and
    - (B) of the means by which such technology achieves such capability (e.g., windowing, utilization of four digit year fields, etc.), and also, the head of the agency, or his or her designee, has reasonably concluded that such agency's interchanging technology will accurately exchange with such third party's technology date/time data from, in, and between the twentieth and twenty-first centuries and from, in, and between the years 1999 and 2000; or
  - (2) such agency's interchanging technology has been reasonably determined by the head of the agency, or his or her designee, to be capable of accurately receiving, retrieving, processing, providing, and outputting date/time data from, in, and between the twentieth and twenty-first centuries, and from, in, and between the years 1999 and 2000 following end-to-end testing (i.e., involving the transmission of data derived from sample transactions from the point of data input to the point of completing the processing, providing, or outputting of data utilizing the interchange, provided such sample transactions satisfy the same standards of comprehensiveness as defined by each agency for testing of all other agency-owned, -controlled, or -operated technology within the agency).

- <u>Y2K-ready as applied to vendor and supplier issues</u> means that one of the two following conditions is satisfied:
  - (1) a supplier or vendor has provided written confirmation to the agency that the technology directly or indirectly associated with its internal systems, its products, and the provision of its services (including, but not limited to, information technology, embedded systems, and any other electro-mechanical or processor based system) accurately receives, retrieves, processes, provides, and outputs date/time data from, in, and between the twentieth and twenty-first centuries, and from, in, and between the years 1999 and 2000, or
  - (2) the head of the agency, or his or her designee, has reasonably determined, based on information obtained by the agency from the supplier or vendor, that the supplier's or vendor's products or services will not fail or malfunction as a result of, or be delayed, interrupted, or degraded, or otherwise adversely affected by, the failure of any technology used by the supplier or vendor (including, but not limited to, information technology, embedded systems, or any other electro-mechanical or processor based system) to accurately receive, retrieve, process, provide, and output date/time data from, in, and between the twentieth and twenty-first centuries, and from, in, and between the years 1999 and 2000.
  - Y2K-ready as applied to embedded systems or processes means that all technology forming part of, utilized in, or associated with the embedded system or process will accurately receive, retrieve, process, provide, and output date/time data from, in, and between the twentieth and twenty-first centuries, and from, in, and between the years 1999 and 2000.

In order for a function to be considered Y2K-ready for this report, an agency must 1) be 100% Y2K-ready with all of the components of the function (computer systems, data interchanges, embedded systems, vendor and supplier issues, and other factors) and must 2) have listed a readiness target date on or before the closing date of this report.

#### Charts 3, 4 and 5: Description and Status of Tier 1, 2, and 3 Functions by Agency

Charts 3, 4 and 5 list the names of Tier 1, 2 and 3 functions, estimated completion dates, and percentage Y2K-ready for each agency. A function assigned to Tier 1 indicates that, in the agency's view, this program, function, or service could not be interrupted for more than one day without endangering the public health, welfare, or safety of the citizens of the State of Illinois or seriously impacting the State's revenue streams. Tier 2 functions are those that could not be interrupted for more than one week, and Tier 3 functions are all others.

As previously noted, in order for a function to be reported as being Y2K-ready, the function must be listed by the agency as being 100% complete and have an estimated Y2K-ready date on or before the closing date of this report. The target Y2K-ready date that appears on the report is the latest completion date of any of the components that support that function.
